**RESIGNATION, DESIGNATION AND APPOINTMENT OF  
MEMBERS OF THE ARCHITECTURAL CONTROL COMMITTEE OF

THIS INDENTURE, made this 13<sup>th</sup> day of May in the year Two Thousand and Twenty (2020) by and between Rod Wright and Melissa Wright (the "Committee Members of the First Part") and Stephen Nashatker and Shadwick Vick (the "Committee Members of the Second Part").

WITNESSETH:

WHEREAS, The Declaration of Restrictions and Protective Covenants (the "Declaration") for the Subdivision of Oakley Estates ("Oakley Estates") in Fayette County, Georgia, are recorded in Deed Book 1739, Pages 413-417, Fayette County, Georgia Records;

WHEREAS, the Declaration provides that the members of Architectural Control Committee (the "Committee") of Oakley Estates are Rod Wright and Melissa Wright;

WHEREAS, the Declaration further provides that "in the event of resignation of any Committee Member, the remaining Member shall have the right to designate a successor"; and

NOW THEREFORE, the Committee Members of the First Part and the Committee Members of the Second Part do hereby make and accept the following resignations, designations, and appointments of members of the Committee in the order set forth below:

1. Melissa Wright does hereby resign as a member of the Committee;
2. As the remaining member of the Committee, Rod Wright does hereby designate and appoint Stephen Nashatker as the successor member to Melissa Wright;
3. Rod Wright does hereby resign as a member of the Committee;
4. As the remaining member of the Committee, Stephen Nashatker does hereby designate and appoint Shadwick Vick as the successor member to Rod Wright; and

THIS INDENTURE shall be effective upon the filing hereof in the Office of the Clerk of Superior Court of Fayette County, Georgia.
